ACQUISITION OF METRIC-AMANO MULTI-SPACE METERS OR EQUIVALENT COMPATIBLE WITH THE ASLAN SYSTEM

WHEREAS, The Parking Authority of the City of Elizabeth has determined a need for multi-

space meters to function with the Parking Authority ASLAN system, a propriety system; and

WHEREAS, the bidder has complied with N.J.S.A. 10:5-31 et. seq. And N.J.S.A. 17:27; and

WHEREAS, on Thursday October 7, 2021 the bids were open with a sole responsive and responsible bidder; and

WHEREAS, Amano McGann, Inc., providers of the Metric Multi-space meters, located 140 Harrison Avenue, Roseland, NJ 07068, is the lowest responsible and responsive bidder; and

WHEREAS, these Multi-space meters selected are the Metric Sprite version, compatible with the ASLAN system used by the Parking Authority and these meters will be place Citywide;

NOW, THEREFORE BE IT RESOLVED that the Commissioners of the Parking Authority of the City of Elizabeth authorizes the award of the contract to Amano McGann for 12 multi-space Sprite meters at a cost of \$9995.00 each and freight at a cost of \$1975.00 for a total amount not to exceed \$121,915.00.
